### **SPECIAL CONDITIONS**

5. A one-time surcharge of \$344,751 shall be imposed to all customers to offset the authorized but not collected revenue from October 1, 2010, the effective date of the interim rates, through June 3, 2012, the date final rates authorized by Resolution W-4916 were effective. The surcharge shall be collected over a period of 36 monthly billing periods and it is based on service charge rates and quantity rates. The quantity rates surcharge shall be charged per Ccf of water sold.
