3. A late charge will be imposed per Schedule No. LC.
4. In accordance with Section 2714 of the Public Utilities Code, if a tenant in a rental unit leaves owing the company, service to subsequent tenants in that unit will, at the company's option, be furnished on the account of the landlord or property owner.

8. As authorized by the California Public Utilities Commission, a one-time surcharge of \$389,493.39 shall be imposed to all customers to recover the planning, studying and engineering costs for improvements to NGWC's water system to enable the utility to maintain safe drinking water standards as approved by Resolution No. W-4778. This surcharge shall be imposed for a period of five years and it is based on service charge rates, from which, surcharge rates for the first year will include a twenty percent reserve of the annual revenue requirement in accordance with the SWRCB Loan Agreement No. D15-02017 dated September 21, 2015. The first year surcharge rates will be as follows:
